1 <u>ORDER</u> The Court, having considered the parties' Stipulation for Modification of Asset 2 Freeze to Allow Release of Frozen Assets to the Court-Appointed Receiver 3 ("Stipulation"), and for good cause shown, it is hereby ORDERED that the Stipulation is 4 5 GRANTED and the Preliminary Injunction and Orders (1) Freezing Assets; (2) Prohibiting the Destruction or Alteration of Documents; (3) Granting Expedited 6 Discovery; (4) Requiring Accountings; and (5) Appointing a Permanent Receiver 7 ("Preliminary Injunction") (Dkt. No. 48) is hereby modified to permit the release of 8 frozen assets held by non-party Coinbase, Inc. ("Coinbase"), a licensed and regulated 9 coin exchange, and Defendant Michael Alan Stollery aka Michael Stollaire ("Stollaire") 10 as follows: 11 12 1. Coinbase is authorized to release all ether which is currently being held in a 13 Coinbase account in the name of Stollaire, under User ID: ******************70001f0, to Mr. Josias N. Dewey ("Dewey"), as the Court-14 appointed receiver for Titanium Blockchain Infrastructure, Inc. ("TBIS"), to be 15 deposited into a Coinbase account established and directed by Mr. Dewey 16 ("Coinbase Receivership Account"); 17 18 2. Stollaire releases any right, title or interest in and to the Trezor Assets and Electroneum, as further described in the parties' Stipulation; and 19 3. The Receiver is authorized to reimburse attorney Andrew Holmes up to \$50,000 20 in legal fees directly associated with his representation of Stollaire in the DOJ's 21 22 criminal investigation. 23 IT IS SO ORDERED.
